JUDGMENT ENTRY

The matter now before the Court is Plaintiff Gary D. Bishop's Motion to Supplement this Court's June 1, 1998 entry designating Lonny Bristow a vexatious litigant pursuant to R.C. 2323.52. Also before the Court is nonparty Annette Windsor's Motion to Intervene.

The Court finds that Lonny Bristow effectuated a name change in the Commonwealth of Kentucky District Court of Justice for Marion County Case No. 19-P-00134. The Court finds that Lonny Bristow has adopted this moniker and may be known in the State of Ohio by this name.

The Court further finds that there is not a basis in law for nonparty Annette Windsor to intervene in the present matter. Further, the relief prayed for by nonparty Windsor has been granted.

It is, therefore, **ORDERED, ADJUDGED, and DECREED**, that the alias "Joseph Clark" be added to the Ohio Supreme Court's vexatious litigant record for Lonny Bristow. All provisions of the June 1, 1998 Order remain in full force and effect.

It is further **ORDERED** that Annette Windsor's motion to intervene is denied as moot.

It is further **ORDERED** that the Clerk of Court shall, pursuant to Ohio Civil Rule 58, serve upon all parties not in default for failure to appear, notice of the within entry and its date of entry upon the journal. Within three days of entering judgment upon the journal, the Clerk shall serve the parties in a manner prescribed by Ohio Civil Rule 5(B) and note the service in the appearance docket. The Clerk shall send a certified copy of this Entry to the Clerk of the Ohio Supreme Court pursuant to R.C. 2323.52(H).

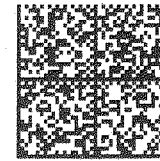
