**[PROPOSED] ORDER ADOPTING MAGISTRATE'S DECISION GRANTING PLAINTIFF'S
REQUEST TO HAVE DEFENDANT DECLARED A VEXATIOUS LITIGATOR**

This matter is before the Court on Magistrate Myron A. Thompson's Decision granting Plaintiff Amazon.com Services, LLC's ("Plaintiff") request to have Defendant Michael Asamoah ("Defendant") declared a vexatious litigator pursuant to Ohio Revised Code § 2323.52. Having reviewed Magistrate Thompson's Decision, along with the case file to date, the Court hereby **GRANTS** Plaintiff's request and declares Defendant a vexatious litigator.

Accordingly, being fully advised in this matter, the Court hereby **ORDERS** the following:

1. Plaintiff's request is **GRANTED**;
2. Defendant is declared to be a vexatious litigator under Ohio Revised Code § 2323.52;
3. Defendant is prohibited from instituting or continuing:
 - a) Any legal proceedings in the court of common pleas, municipal court, or county court without first seeking and obtaining leave of court to proceed; and
 - b) Any appeal without first seeking and obtaining leave of court to proceed.
