Human Trafficking vs. Prostitution

- Prostitution is defined:
 - Ohio Revised Code 2907.24:
 - No person... shall **engage in sexual activity for hire**.
 - Effective date 2,000 B.C.
 - Worlds oldest profession, or worlds oldest oppression?
- Human Trafficking is defined:
 - Ohio Revised Code 2905.32:
 - (A) No person shall recruit, lure, entice, isolate, harbor, transport...another person knowing that the person will be compelled to **engage in sexual activity for hire**, engage in a performance that is obscene, sexually oriented, or nudity oriented, or be a model or participant in the production of material that is obscene, sexually oriented, or nudity oriented.
 - (B) ..."Compelled" does not require that the compulsion be openly displayed or physically exerted. The element of "compelled" has been established if...the victim's will was overcome by force, fear, duress, or intimidation.
 - Effective date 6-27-2012.

- Pimp Interview

How to Detain

- Once lured in, they must be detained.
 - Relationships quickly move from "friendship" to "love" (sexual), then to "business."
- Use wartime, cultist, and terrorist prisoner control tactics.
 - Emotional, physical, sexual violence.
 - Drugs and economic dependence.
 - Isolation from friends, family, public to eliminate ability to build supportive social networks.
 - Fathering a child to further tighten control.
 - Filing charges against women and having them jailed.
- Re-identification: new identity (stage name), remove identity documents...to further limit a victim's ability to escape.

Recognizing a Human Trafficking Victim

- In the company of a significantly \_\_\_\_\_ man. Individual may introduce as a family friend, relative, supporter, coach.

## Recognizing a Human Trafficking Victim

- Inability/fear of making \_\_\_\_\_.
- Makes references to frequent \_\_\_\_\_.
- \_\_\_\_\_ distress such as depression, anxiety, panic-attacks, confusion, phobias, disorientation, self-inflicted injuries.
- Shows signs of \_\_\_\_\_.

## How do we respond to a victim? Trauma-Informed Care

- Trauma: results from an event, series of events, or set of circumstances experienced by an individual physically or emotionally harmful or threatening and has lasting adverse effects on the individual's functioning and psychological, social, emotional well-being.
- Understanding that people's feelings, behaviors, and symptoms are adaptations/strategies to survive...real protection unavailable...person's \_\_\_\_\_ are overwhelmed.

- Best understood as \_\_\_\_\_ to \_\_\_\_\_ and are logical in context of trauma...challenging for justice experts their behavior.

## Trauma-Informed Response

### Building Trust

- Your interaction sets tone...critical. Treat them like a victim of violent crime.
- You do NOT need to know all the details...do not cast judgment. "No Shame Zone."
- Look at them in the eyes with care and concern, and listen...indicating they are important, valued, and worthy.
- Never promise anything you can't deliver.
- Focus on safety...emotional and physical.
- Transparent, consistent, flexible...

Solutions:  
*Exit Strategy*

- C.A.T.C.H. Court begins
  - Provide 2 year intensive probation and services to help victims exit prostitution
  - Establishment of comprehensive community based treatment to help women exit prostitution
    - Amethyst, Maryhaven, and Freedom ala Cart
  - Recognize prostitution as VIOLENCE and EXPLOITATION against women and girls

Solutions

- Court session every week to report progress...key ingredient
  - Women helping women, learn to use voice, held accountable
  - Process starts with an attorney referral and clinical assessment.
  - Staffing process...everybody brought to the table.

Solutions

- Clients reporting to staff every day. In treatment.
  - Need a lot of support...but the difference between them and most other defendants...they want the help and are grateful (glasses, clothes to reconstructive surgery)
- Curfew, stay-away zones, drug testing, counseling, needs being met
- People, places, things: triggers for trauma victims

## CATCH Results

*Evaluation Study of a Criminal Justice Reform Specialty Court-  
CATCH Court. K. Miner Romanoff (2015)*

- \_\_\_\_\_% of women accepted into CATCH no new criminal charges. (reduced arrests overall)
- \_\_\_\_\_% felt \_\_\_\_\_ in the program.
- Most helpful part of success: \_\_\_% staff, \_\_\_% Judge.
- \_\_\_\_\_% of graduates were either employed, volunteering, or enrolled in educational programs of vocational training.
