**JUDGE WANTS TO KNOW WHY JUVENILE COURT WON'T HAND OVER RECORDS**

Lorain County Common Pleas Judge Mark Betleski wants to know why the county's Juvenile Court has refused to turn over mental health records for a former juvenile defendant now facing a capital murder charge. If he doesn't get a satisfactory answer at a hearing later this month, he may hold the legal custodian of the records in contempt of court, which could mean fines or jail time. [More...](#)

**ASIAN ELEPHANT CURED IN REHAB OF HEROIN ADDICTION: DRUG TREATMENT WORKS FOR ANIMALS OF ANY SIZE**

An Asian elephant that became addicted to heroin at the hands of illegal traders will return home after a three-year rehab program, Chinese state media said Thursday. Xiguang, a 4-year-old male Asian elephant, became addicted after he was captured by smugglers along the Chinese-Myanmar border in March 2005. **CRIMINALLY INSANE MONITORED FOR YEARS**

Even if Yusef DeJarnette is allowed to live in a group home, he is likely to be under court scrutiny for decades. A Cuyahoga Common Pleas judge will decide in coming weeks whether DeJarnette should be allowed to leave a state psychiatric facility where he has been treated since shooting two people in 2002. A new state Medicaid rule requiring pre-authorization for dispensing a handful of costly mental-health drugs will take effect without objection from a state legislative panel. Mental-health advocates, speaking at yesterday's meeting of the Joint Committee on Agency Rule Review, said the rule will have "dire consequences for those who need these medications." Interjecting the state between the doctor and patient is "ill-advised and not fiscally responsible," said James Mauro, executive director of the National Alliance on Mental Illness Ohio. ## **NEW RESOURCE: IMPROVING LAW ENFORCEMENT RESPONSES TO PEOPLE WITH MENTAL ILLNESSES**

The [Council of State Governments Justice Center](#), in partnership with the [Police Executive Research Forum](#), has identified 10 key ingredients found in successful law enforcement initiatives to provide better outcomes in officers' encounters with individuals with mental illnesses. They are outlined in *Improving Responses to People with Mental Illnesses: The Essential Elements of a Specialized Law Enforcement–Based Program*.

According to this [Bureau of Justice Assistance](#)–supported publication we are now making available, law enforcement officers nationwide regularly respond to calls for service that involve people with mental illnesses. On rare but highly publicized occasions, these incidents result in injury or death for the individual, officer or others at the scene. More often, officers find they spend long periods of time on these complex repeat calls for service only to see the person cycling through the criminal justice system without any positive long-term effect. ## **STUDY FINDS WORKPLACE PRODUCTIVITY OF PERPETRATORS OF INTIMATE PARTNER ABUSE IS AFFECTED**

New research suggests that greater propensity for abusiveness is associated with missing work and experiencing worse productivity on the job, according to researchers Emily Rothman of the Boston University School of Public Health and Phaedra Corso of the University of Georgia College of Public Health. The research appears in the September 2008 issue of *Violence Against Women*, Volume 14, Number 9, 1054 – 1064.

The researchers found:

- Male employees score on the Propensity for Aggression Scale (PAS) predicted their workplace productivity in several ways, including the likelihood that they made mistakes on the job, missed work time, and were physically present but less than optimally productive while at work.
- A statistically significant relationship between the PAS score and an employee's overall health – in other words, more abusive employees appeared less health and less productive than less abusive employees
- 39% of the respondents indicated they would attend a stress reduction workshop if offered at work, 21% indicated they would attend a relationship skills workshop, 10% would attend a job safety workshop, and 8% would attend a positive parenting workshop – and this was true whether the employee had a higher PAS score or not\*

The Staff of the Specialized Docket Section of the Supreme Court of Ohio wishes to share with you the posting of a new state position that will significantly impact state policy and programs regarding at-risk and/or adjudicated youth with mental health treatment needs in Ohio. The attachment contains the basic information which can be found on the state's Ohio Hiring Management System. By clicking on the official job title above, you will be linked to the position on the website which includes the link to the application process.

The official job title is Mental Health Administrator 6, but this position has also been referred to in some circumstances as the Juvenile Justice Mental Health Coordinator. One of the items that this person will be responsible for coordinating is the legislative proposal developed by the Juvenile Competency Working Group of the Supreme Court of Ohio Advisory Committee on Mental Illness and the Courts. From juvenile competency on the front of the system to re-entry related issues on the back end, the Administrator will be interacting with not only several state agencies, but with the Governor, the Legislature and the Judicial Branch. This position will be housed and staffed through the Ohio Department of Youth Services, but may be accurately described as inter-governmental in scope.

Since there is a desire to quickly bring someone into this position, there is a short application window. **The deadline to apply is 11:59 pm on Monday – September 15.** Please review this position description and share this with anyone you believe to be appropriate.
