#### THE OHIO SPECIALIZED DOCKETS PRACTITIONER NETWORK



#### JAILS ENSURE INMATES GET NEEDED DRUGS

After R&B Singer Sean Levert died last March in the Cuyahoga County Jail, his widow filed a wrongful death lawsuit alleging that Levert was not provided an adequate medical assessment nor was he provided adequate mental health screening and care. The lawsuit filed in U.S. District Court in Cleveland also argues that jail officials didn't notify the jail pharmacy that Levert required a prescription for the anti-anxiety drug Xanax or its equivalent. #### MEETING ON APARTMENT PLAN DRAWS MORE THAN 100 CITIZENS

Since the end of January, Ward 6 residents have been concerned about a 14-unit apartment complex called Cardinal's Peak proposed on Charles Street for persons with disabilities. On March 3 more than 100 citizens attended a public meeting hosted by the city's administration at the Natatorium, and several voiced concerns about issues such as public notification, zoning, traffic, property values, emergency access and child safety. <a href="More...">More...</a>

The body, covered by a white sheet and bathed in the stark beam of a police officer's flashlight, looked forlorn and out of place on the cold, dark highway. A core part of the National Alliance on Mental Illness of Ohio (NAMI Ohio) mission is to provide free training to dispel the myths about mental illness and to promote understanding. NAMI Ohio will come to your site to provide a free one-day training for jail and court personnel who regularly encounter individuals (adults and/or juveniles) with mental illness. ### HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT (HIPAA): MYTHS, FACTS, AND CROSS-SYSTEM COLLABORATION

### TOOLKIT FOR SECOND CHANCE ACT REENTRY DEMONSTRATION PROJECT GRANT APPLICANTS

The Council of State Governments Justice Center has developed a toolkit for state and local governments and Indian tribes interested in responding to the solicitation for state and local reentry demonstration projects released on February 27, 2009, by the Bureau of Justice Assistance (BJA), U.S. Department of Justice. The toolkit, developed with support from the Public Welfare Foundation, Annie E. Casey Foundation, Joyce Foundation, and Open Society Institute, includes materials that can help potential applicants think through the questions asked in the solicitation and design or enhance their reentry initiative. Those that are currently available are:

- 1. A checklist that will help state and local governments and Indian tribes meet application requirements under Section 101 of the Second Chance Act (PDF)

## JUVENILE SEX OFFENDER TREATMENT PROGRAMS CAN MAKE REQUESTS TO THE OHIO DEPARTMENT OF YOUTH SERVICES (ODYS) FOR CERTIFICATION

Pursuant to the enactment of Senate Bill 10, juvenile sex offender treatment programs can make requests to the Ohio Department of Youth Services (ODYS) for certification. Sex offenders, who petition courts for early termination of the duty to register, must complete a certified sex offender program. 2950.16 of the Ohio Revised Code requires ODYS to periodically inspect and certify sex offender and child-victim offender treatment programs that request certification. ODYS has established the Juvenile Sex Offender Treatment Program Certification Advisory Board to administer the juvenile sex offender treatment program certification in Ohio.
