HOW CAN MARION REDUCE POVERTY?

Some community members plan to take steps toward reducing poverty in the area. Others already are. Using the book "Bridges Out of Poverty" and other guides, and taking concepts from training sessions in January and this week, an effort initiated by Marion Municipal Court is pushing forward. It started after officials participated in similar sessions hosted by the Ohio Supreme Court. More...

INVOLUNTARY COMMITMENT PROCESS FOR DEFENDANTS FOUND NOT COMPETENT TO STAND TRIAL IS CIVIL IN NATURE

The Supreme Court of Ohio ruled that the involuntary commitment of a criminal defendant who is charged with a violent first or second-degree felony and who remains mentally incompetent to stand trial beyond the one-year statutory time frame for restoring competency does not violate that person's constitutional rights to due process or equal protection. More...

DO RESTRAINING ORDERS WORK?

Kayelee Martin took out a restraining order against ex-boyfriend Todd O'Brien in March. Three months later, the 23-year-old Painesville Township woman was dead. O'Brien, 25, of Eastlake, is accused of striking Martin with his car after he saw her with her son and new boyfriend. Martin told a 911 operator O'Brien had repeatedly called and threatened to hit them with his car. More...

REPORT: VICTIM SERVICES LACKING IN HUMAN-TRAFFICKING CASES

The story of a 14-year-old girl from rural Ohio might sound like the plot of a bad movie, but it's a real-life human-trafficking horror story.

The girl was befriended by an older man who plunged her into sex trafficking in a nearby city. When she was arrested in a hotel with another older man, police charged her with a curfew offense that was a probation violation and sent her to a juvenile-detention center. The "john" and the trafficker were not charged. More...

BETTER ENFORCE LAWS IN HUMAN TRAFFICKING

Forcing women into prostitution may seem like the stuff of movies and television crime shows - but it can happen. It did happen in Ohio.

Authorities say four men convinced as many as a dozen women from the Chillicothe area to go with them to Baltimore. It is not believed the women knew what was in store for them. Once in Baltimore, the women "were beaten into submission, threatened with guns and plied with drugs until they were dependent on their captors for their habit," according to a published report. Then they were forced to become prostitutes. More...

PROBATION, PAROLE FOR NONVIOLENT CRIME COULD SAVE STATES \$15B

State and local governments across the nation could reduce their corrections budgets by 25 percent for a total savings of \$15 billion if they were to place half of their non-violent criminals on probation or parole instead of in prisons and jails, according to a new study by a Washington, D.C. think tank. More...

PROPOSED SOLUTIONS TO PRISON CROWDING PROBLEM WOULD UNDO OLD LAWS

Tough-on-crime laws have left prisons bursting at the seams, causing state officials and lawmakers to rethink the way justice is meted out in Ohio. Some reform proposals would undo laws that caused prison rolls to explode since the 1980s. More...

COURT CLARIFIES ROLE OF COUNTY DEVELOPMENTAL DISABILITIES BOARD IN ACTION TO REMOVE GUARDIAN

The Supreme Court of Ohio ruled that although a county board of developmental disabilities does not have legal standing to file a motion in probate court seeking the removal of a court-appointed guardian for an incompetent adult, the probate court has plenary authority to sua sponte (on its own initiative) conduct proceedings to remove a guardian based on information received from that board. More...

NEW COURT HELPS STRUGGLING VETS

Tony Leech saw combat action in Iraq during Operation Desert Storm. He was shot in the head in Somalia. Leech, 38, served his country from 1991 to 1998 in the U.S. Army. As difficult as his stint in the military was, his return to civilian life wasn't much better. Leech has been in and out of court the last decade and continues to fight drug addiction. He is indicative of veterans who struggle when they come home. More...

SETTLEMENT REACHED IN LAWSUIT ON SINGER SEAN LEVERT'S DEATH IN CUYAHOGA COUNTY JAIL

The widow of singer Sean Levert, who died six days after entering Cuyahoga County Jail in March 2008, has settled her lawsuit against the county and the company that oversees medical care in the jail for \$4 million. The settlement with the county and Midwest Medical Staffing Inc. was reached late Wednesday after a nine-hour mediation conference with U.S. District Magistrate Judge Greg White. More...

SCAMMERS TARGETING NEEDY IN OHIO

Ohio Attorney General Richard Cordray is warning Ohioans who use the Ohio EPPICard program to access public assistance cash benefit payments such as Ohio Works First and Disability Financial Assistance, that they could now be the target of a new scam. The Attorney General's office has received complaints from Ohioans who have reported scams involving these public assistance debit cards. "In most of the complaints that we received, consumers were contacted through text messages," said Cordray. "They were told that their EPPICard had been frozen and that they needed to call a phone number. After calling the number, the consumers were prompted to enter account and pin numbers. This is a typical phishing scam, and under no circumstances should consumers ever provide account information to unidentified sources."

OCJS AND OHIO PRESCRIPTION DRUG GRANT

Deadline: July 12, 2010

The focus of this grant is to target organized illegal prescription drug cases that involve source targets. Generally, source targets are those responsible for knowingly making the abuse possible by supplying users through illegal or unlawful means as defined by state and federal law. Proposed to defray the expenses incurred during a prescription drug investigation related to illegal prescription drug abuse, the Ohio Prescription Drug Grant provides agencies with funding to investigate and prosecute these types of cases. The solicitation release date will be **June 11** and proposals will be due by **July 12.** Award notifications of funding will be released on **August 30**. Agencies may apply for a maximum of \$15,000 in federal funds to investigate and prosecute substantiated prescription drug cases. No match is required for this grant program. However, the applicant should be able to show the agency's vested interest by supplying personnel, equipment, etc. to supplement the investigation.

The National Institute of Mental Health (NIMH), National Institute on Alcohol Abuse and Alcoholism (NIAAA), and the National Institute on Drug Abuse (NIDA) will fund research that will reduce the burden of suicidality (deaths, attempts, and ideation). Funding is intended to intensify investigator-initiated research on the topic, attract new investigators to the field, and increase interdisciplinary approaches to developing effective strategies to reduce suicidality. Mental disorders, along with alcohol use disorders (AUDs) and substance use disorders (SUDs), are of particular interest as they pertain to risk and protective factors and treatment efficacy and effectiveness for suicidality.
