#### \$36M TO BE USED TO FIGHT PRESCRIPTION DRUG ABUSE IN OHIO

Gov. John Kasich on Tuesday announced \$36 million in federal and local funds would be used to fight the scourge of prescription drug abuse, which now accounts for more deaths statewide than car accidents or suicides. Alcohol, Drug Addiction and Mental Health Services boards across the state will chip in \$8.9 million as a local match to qualify for \$27 million in federal money, which is from the Department of Education's Rehabilitative Services Administration. # WOULD INCREASED SENTENCING OPTIONS EASE BURDEN ON OHIO'S STRAINED PRISONS?

Brian A. Siler has pleaded guilty to seven low-level felonies since 2001, putting him in jail or in prison for six years and seven months. His sentences ranged from seven months for stealing a credit card to one year for possessing a stolen car to three years for aggravated burglary. Now he is out of jail on his own recognizance on a felony domestic violence indictment. He has pleaded guilty to a misdemeanor violation of a protection order in the same incident. # DRUG OFFENDERS MAY QUALIFY FOR GUN OWNERSHIP AFTER CUYAHOGA COUNTY JUDGE'S DECISION

A Cuyahoga County judge's decision to allow a convicted drug criminal to own firearms for self-defense could pave the way for thousands of people with minor drug convictions to own guns. At issue is whether an Ohio law prohibiting all drug criminals, among others, from owning guns is unconstitutional when applied to someone convicted of a misdemeanor drug charge. More...

#### MEDINA COUNTY DRUG COURT HAS HIGHS & LOWS, BUT NO EXCUSES

Common Pleas Judge Christopher J. Collier said he's exhausted by midday every Monday. He starts out the week with his call day, when dozens of felons and accused felons appear before him to be arraigned, face probation violations or receive their sentences. Drug court administrator Christine Demlow and Common Pleas Judge Christopher J. Collier talk to drug court participants Wednesday. The rigorous year-long program has low-level drug offenders going to weekly sessions at the courthouse and meeting other objectives to eventually have charges against them dropped. Collier said it's possible he'll see many of these people again, even after their cases are resolved. More...

# VA EXTENDS POST-INCARCERATION HEALTH CARE: MEASURE WOULD HELP REDUCE REPEAT OFFENSES

The Department of Veterans Affairs (VA) will extend health care to eligible Veterans in halfway houses and other temporary, post-incarceration housing under a new program aimed at cutting back on repeat offenses. "There's hard evidence that lack of access to health care, including mental health care, for newly released inmates is a factor in people becoming homeless or returning to prison and

jail," said Jim McGuire, director of VA's Veterans Justice Outreach Programs. "These are Veterans who otherwise qualify for VA health care." A long-standing rule has barred VA from providing health care to Veterans for whom another federal, state or local government has an obligation to provide health care. Frequently, that means inmates of prisons and jails. Under the changed rule, that prohibition would be amended and VA would be allowed to provide health care to Veterans in halfway houses and other temporary, post-incarceration housing. An Urban Institute study in 2008 found that good health care in the first months of community reentry played a key role in easing readjustment and reducing recidivism. About 29,000-56,000 Veterans are released annually from state and federal prisons, and at least 90,000 Veterans are released each year from city and county jails, according to Department of Justice's Bureau of Justice Statistics.

#### GOVERNOR SAYS CHANGES TO THE PRISON SYSTEM ARE OVERDUE

The proposed re-opening of the Marion Juvenile Correctional Facility was the subject of a Monday press conference by Gov. John Kasich and the Ohio Department of Rehabilitation and Correction. Residents, government officials and community leaders heard the governor and others speak about how the sale and privatization of the prison and the neighboring adult facility at North Central Correctional Institution will bring jobs to the area and revenue to local government. # **REHABILITATION FACILITY TO CLOSE JUNE 30**

Despite efforts to find local funding, the Licking-Muskingum Community Correction Center, which provides rehabilitation to nonviolent offenders, will close June 30. On March 2, the Ohio Department of Rehabilitation and Correction cut the facility's \$1.8 million grant. The center, which serves Licking, Richland, Knox, Muskingum and Coshocton counties, had until April 1 to inform the state if it could continue. More...

# NO ROOM IN JAIL; NO-SHOW IN COURT

Some nonviolent offenders who are being released from jail in the wake of deep cuts to Stark County's general fund budget are failing to show up for court, according to Massillon Municipal Court judges Edward Elum and C. Roland Centrone. Instead of being booked into the county jail, prisoners are being granted emergency releases after signing personal recognizance bonds. The move is designed to save bed space at the jail, which is now operating as a 300-bed facility due to a 16 percent budget cut. More...

# **JAILING DEADBEAT PARENTS A FORM OF DEBTORS' PRISON?**

Nearly two centuries ago, the U.S. Supreme Court abolished the practice of imprisoning those who are too poor to pay their legal debts. But the threat of jail time still exists for poor people who are delinquent on child-support payments. "It's a heinous situation," said Michael McCormick, executive director for the American Coalition for Fathers and Children. "Jail just becomes a revolving door. Child-support lockups are debtors' prisons." More...

# **JAILS FACE TOUGH BUDGET QUESTIONS**

Coshocton Municipal Court had a 96 percent conviction rate in drunken driving cases in 2009, according to the latest statewide court statistics released by the Ohio Supreme Court. But where to put those convicted of local crimes – jail sentences or driver intervention and treatment programs are typical – is a looming concern due to proposed state budget cuts. More...

# STATE BACKPEDALS ON MOVING WOMEN OUT OF CLEVELAND PRISON TO ONE IN DAYTON

State prison officials are reconsidering a plan that would move more than 400 women from a prison in Cleveland to one in Dayton, and convert the facility on East 30th Street to hold male inmates. The shift had been part of a larger plan to save money and cut down on gang violence in the prison system. More...

# NEW FAQ: THE IMPLICATIONS OF FEDERAL HEALTH LEGISLATION ON JUSTICE-INVOLVED POPULATIONS

This month marks the one-year anniversary of the passage of federal health reform legislation. The Patient Protection and Affordable Care Act improves access to health care for individuals leaving prison and jail—many of whom have significant health needs—in part by expanding eligibility for Medicaid to nearly all low-income populations. The Council of State Governments Justice Center (which coordinates the Criminal Justice/Mental Health Consensus Project) recently released a frequently asked questions document, "The Implications of Federal Health Legislation on Justice-Involved Populations." This FAQ examines how the health reform legislation expands these adults' eligibility for Medicaid and what services will now be available to them, the requirements and exemptions specified by the legislation, and how Medicaid enrollment will take place. To download this FAQ, click here. This is the first release in a four-document series by the CSG Justice Center on the intersection of behavioral health and the criminal justice system. Soon-to-be-released publications will include an FAQ on behavioral health disorders and people returning from prison and jail; a guide on how to maximize opportunities for Medicaid enrollment for people returning from prison and jail; and a follow-up health reform report that looks at the way the legislation is implemented at the state and local levels. # JUVENILE JUSTICE SYSTEM IMPROVEMENT PROJECT

The Juvenile Justice System Improvement Project (JJSIP) is designed to help states improve outcomes for juvenile offenders by better translating knowledge on "what works" into everyday practice and policy. The JJSIP takes the vast amount of knowledge gained through Dr. Mark Lipsey's meta-analysis of effective juvenile justice programs and embeds it within the Office of Juvenile Justice and Delinquency Prevention's Comprehensive Strategy for Serious, Violent, and Chronic Juvenile Offenders as developed by Dr. James C. Howell and John Wilson. In doing so, the JJSIP provides a framework for improving juvenile justice practice throughout the entire juvenile justice continuum. CJJR is currently accepting Letters of Interest for the JJSIP!
