#### A CASE OF COST AND MORAL OBLIGATION

"I sentence the defendant to two years of rape for the crime of . . . ." You can be assured you'll never hear a sentence like that delivered from any bench. Ever. And yet, year after year, thousands of men, women and juveniles emerge from America's prisons and jails having served time for their misdeeds — plus a side sentence that never appeared on any document, delivered sometimes by staff, and sometimes by fellow inmates: rape. #### YOUTH-LED PREVENTION PSA CONTEST

Do you have a mission and a message that you want your community and the entire State of Ohio to receive about prescription or over-the-counter (OTC) drug abuse prevention? If so, here is your chance to make that happen. The Ohio Department of Alcohol and Drug Addiction Services (ODADAS) Division of Prevention Services has announced the first-annual ODADAS PSA (public service announcement) Contest. The goal is for youth of Ohio to address prescription or over-the-counter drug abuse prevention through PSAs that will educate, motivate and call viewers to action! The PSAs will be uploaded to the ODADAS <u>Facebook page</u> where they will be voted on by the number of people who "like" the PSA. The PSAs also will be reviewed by the OPEC Planning Committee, which includes representatives from ODADAS and the Ohio Department of Education, who will make the final determination of the winning PSA. The winner will be announced and recognized at the 2011 Ohio Prevention and Education Conference (OPEC). The winner will work with the ODADAS Office of Communications to potentially have the winning PSA aired in their local market. ### SECOND CHANCE ACT REENTRY PROGRAM FOR ADULT OFFENDERS WITH CO-OCCURRING SUBSTANCE ABUSE AND MENTAL HEALTH DISORDERS FY 2011 COMPETITIVE GRANT

**DEADLINE:** June 23, 2011, 11:59 P.M. Eastern Time.

**OVERVIEW:** The Second Chance Act of 2007 provides a comprehensive response to the increasing number of incarcerated adults and juveniles who are released from prison, jail, and juvenile residential facilities and returning to million individuals serving time in our federal and state prisons, and millions of people cycling through local jails every year. Ninety-five percent of all offenders incarcerated today will eventually be released and will return to communities. The Second Chance Act helps to ensure that the transition individuals make from prison, jail, or juvenile residential facilities to the community is successful and promotes public safety.

**ELIGIBLE PARTICIPANTS:** States, units of local government, and federally recognized Indian tribal governments (as determined by the Secretary of the Interior).

**AWARD INFORMATION:** Awards will be for a period of 24 months. Contingent upon the availability of funds and the number of adult offenders projected to be served, awards of up to \$600,000 each are expected to be made.

### ONLINE COURSES TRAIN JUVENILE JUSTICE MANAGERS

The <u>National Juvenile Court Services Association</u> has designed an online training curriculum to train juvenile justice managers. Sponsored by the Office of Juvenile Justice and Delinquency Prevention, the Professional Juvenile Justice Manager (PJMM) certificate program includes <u>a series of online</u> <u>courses</u>. Students will spend two weeks on each course, working on basic lecture material, specialized readings, and self-assessment questions.

## FROM PROTECTION TO PUNISHMENT: POST-CONVICTION BARRIERS TO JUSTICE FOR DOMESTIC VIOLENCE SURVIVOR-DEFENDANTS IN NEW YORK STATE

Report Issued by the Avon Global Center for Women and Justice at Cornell Law School and the Women in Prison Project of the Correctional Association of New York

The Avon Global Center for Women and Justice at Cornell Law School and the Women in Prison Project of the Correctional Association of New York announce the release of a new study on the barriers to justice faced by women survivor-defendants in New York State: "From Protection to Punishment: Post-Conviction Barriers to Justice for Domestic Violence Survivor-Defendants in New York State." According to Sital Kalantry, Associate Clinical Professor of Law and Faculty Director of the Avon Global Center for Women and Justice at Cornell Law School, "The report released today provides comprehensive qualitative and quantitative evidence to expose the tragic and little understood reality facing survivor-defendants in their interaction with the criminal justice system in New York."

"New York State has an obligation under international law to respect the human rights of survivor-defendants by taking their experiences of abuse into account. The reforms recommended by the report would help New York to realize this international law obligation and to ensure that survivors are treated with fairness and dignity," said Elizabeth Brundige, Associate Director of the Avon Global Center for Women and Justice at Cornell Law School, Adjunct Professor Law, and co-author of the report.

#### Key recommendations of the Report include:

- Allowing judges to sentence domestic violence survivors convicted of crimes directly related to abuse to shorter prison terms and, in some cases, to community-based alternatives to incarceration.
- Providing domestic violence survivors currently in prison the opportunity to appeal to the courts for re-sentencing.
- Allocating funds to expand and establish more alternative-to-incarceration, court advocacy and re-entry programs specifically designed to meet the needs of survivor-defendants.
- Allowing individuals incarcerated for violent crimes, including domestic violence survivors, to earn merit time credits and expanding eligibility for temporary work release.
- Allowing individuals incarcerated for violent offenses, including domestic violence survivors, to have parole release decisions about them made not solely on the nature of the offense for which they are incarcerated but with appropriate weight given to their institutional confinement record and actual public safety risk.

The Report also suggests that the DV Survivors Justice Act, a bill pending in the New York state legislature, is an important way to address some of the major challenges facing survivor-defendants in obtaining justice. Today, over 140 people representing more than 100 organizations across the state will travel to Albany to urge legislators to pass the Act. According to Tamar Kraft-Stolar, Director of the Women in Prison Project at the Correctional Association of New York and co-author of the report, "The DV Survivors Justice Act, which allows judges to send survivors who act to protect

themselves to community-based alternative programs instead of prison, will help reverse the state's misguided and unjust practice of doling out harsh punishments to survivor-defendants instead of providing the assistance and support they need and deserve."
