GRANTS TO EXPAND SUBSTANCE ABUSE TREATMENT CAPACITY IN ADULT TREATMENT DRUG COURTS AND ADULT TRIBAL HEALING TO WELLNESS COURTS Deadline: April 4, 2016

The Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, is accepting applications for fiscal year 2016 Grants to Expand Substance Abuse Treatment Capacity in Adult Treatment Drug Courts and Adult Tribal Healing to Wellness Courts. The purpose of this program is to expand and/or enhance substance use disorder treatment services in existing adult problem solving courts, and adult Tribal Healing to Wellness courts, which use the treatment drug court model in order to provide alcohol and drug treatment (including recovery support services, screening, assessment, case management, and program coordination) to defendants/offenders.

GRANT AWARDS FOR THE COMMUNITIES ADDRESSING CHILDHOOD TRAUMA (ACT) PROGRAM FY 2016

Deadline: April 18, 2016

The Office of Minority Health (OMH) at the United States Department of Health and Human Services announces the availability of funds for Fiscal Year (FY) 2016 for grant awards for the Communities Addressing Childhood Trauma (ACT) Program. ACT is intended to test the effectiveness of innovative approaches in promoting healthy behaviors among minority and/or disadvantaged youth at-risk for poor health/life outcomes due to childhood trauma. These innovative approaches (including curricula) should be designed for minority and/or disadvantaged youth ages 5 to 15 years who have been exposed to childhood trauma, as well as support services to their families. ACT seeks to address unhealthy behaviors in minority youth and provide them with opportunities to learn coping skills and gain experiences that contribute to more positive lifestyles and enhance their capacity to make healthier life choices. ACT funded grantees should serve minority and/or disadvantaged youth and their families who live in communities where they are exposed to chronic traumatic situations repeatedly over long periods of time such as violence (e.g., homicides, nonfatal assaults, school violence, and suicide), domestic violence, some forms of physical abuse, sexual abuse, or neglect, or recovery from disasters or other emotionally harmful experiences. The ACT initiative also promotes the goals of My Brother's Keeper (https://www.whitehouse.gov/my-brothers-keeper), an initiative launched by President Obama to ensure that all young people can reach their full potential, including boys and young men of color.

ADULT DRUG COURT DISCRETIONARY GRANT PROGRAM FY 2016 COMPETITIVE GRANT

Deadline: April 19, 2016

This grant includes three categories:

1) Implementation: $$350,000 \sim 36 \text{ months}$

Jurisdictions that have completed a substantial amount of planning and are ready to implement an evidenced-based program. Priority consideration given to Category 1 jurisdictions that have completed the <u>Drug Court Planning Initiative (DCPI) training</u>.

2) Enhancement: \$300,000 ~ 36 months

Jurisdictions with a fully operational program wanting to:

- Scale up drug court program capacity
- Enhance court operations
- Expand or enhance court operations
- Improve the quality and/or intensity of services based on needs assessments

3) Statewide Enhancement ~ 36 months

- Applicants may request up to \$300,000 to improve, enhance, or expand Drug Court services statewide by encouraging adherence to the evidence-based program principles.
- Applicants may request up to \$1,200,000 to financially support Drug Courts in local or regional
 jurisdictions which do not currently operate with BJA Adult Drug Court Discretionary Grant
 Program funding.

GRANT AWARDS FOR THE RE-ENTRY COMMUNITY LINKAGES (RE-LINK) PROGRAM FY 2016

Deadline: April 21, 2016

The Office of Minority Health (OMH) at the United States Department of Health and Human Services announces the availability of funds for Fiscal Year (FY) 2016 for grant awards for the Re-Entry Community Linkages (RE-LINK) program. The purpose of the RE-LINK program is to improve the health outcomes for minority and/or disadvantaged re-entrants, ages 18-26, in transition from jail to their communities. Based on the disproportionate numbers of racial and ethnic minorities among the incarcerated and formerly incarcerated populations, RE-LINK will target the communities with the greatest rates of minority and/or disadvantaged re-entrants discharged from jail to the community. The RE-LINK program aims to demonstrate the effectiveness of multiple stakeholders within the public health system and other community support systems working together to implement a model transition process. RE-LINK will establish connections, in a culturally and linguistically appropriate manner for the populations being served, between the re-entry population and community-based organizations that provide linkages to health care including behavioral health care services, health care coverage including through the Health Insurance Marketplaces and Medicaid, and other social services such as housing, adult education and employment assistance programs.

SYSTEM OF CARE GRANTS IN THE AREA OF MENTAL HEALTH Deadline: April 26, 2016

The Substance Abuse and Mental Health Services Administration, Center for Mental Health Services (CMHS), is accepting applications for fiscal year (FY) 2016 Cooperative Agreements for the Expansion and Sustainability of the Comprehensive Community Mental Health Services for Children with Serious Emotional Disturbances (Short title: System of Care [SOC] Expansion and Sustainability Cooperative Agreements). The purpose of this program is to improve behavioral health outcomes for children and youth (birth-21) with serious emotional disturbances (SED) and their families. This program will support the wide scale operation, expansion, and integration of the SOC approach by creating sustainable infrastructure and services that are required as part of the Comprehensive Community Mental Health Services for Children and their Families Program (also known as the Children's Mental Health Initiative or CMHI). Eligibility is limited to state and local governments, Indian Tribes and territories. There will be 52 grants awarded. Total amount of funding under this program is around \$53 million.

SJI GRANTS

Deadline: May 1, 2016 and November 1, 2016

The State Justice Institute (SJI) is announcing the availability of five grant categories for state courts, nonprofits, and educational assistance to judges. The categories are as follows:

Project Grants (up to \$300,000 each): to support innovative education and training, demonstration, and technical assistance projects to improve the administration of justice in the nation's courts.

TA Grants (up to \$50,000 each): to provide state and local courts with funding to obtain expert assistance to diagnose a problem, develop a response to that problem, and initiate implementation of any needed changes.

CAT Grants (applicants are required to match not less than 50% of the grant amount requested, of which 20% must be cash): to enable courts to modify and adapt or revise curriculum, train instructors, pilot test the new or revised curriculum, and conduct judicial branch education and training programs.

SIG awards are of varying amounts: these grants are initiated by SJI outside the regular grant process. Recent grants have gone for pressing issues including handling of immigration and human-trafficking cases.

ESP (\$1,000 awards): to provide tuition assistance for state court judges and court managers.

The National Network to End Domestic Violence Fund (NNEDVF) teams up with the Allstate Foundation to support NNEDVF grants to aid domestic violence survivors. The program supports 501(c)(3) nonprofit organizations whose core mission is to serve or represent victims of domestic violence and their children. The effort also provides small grants to survivors of domestic violence (women and their families) to help them achieve their educational and job related goals. Any survivor of domestic violence is eligible to apply; however, the application must be completed by a local domestic violence program or coalition to be

accepted. Applications will be assessed based on the need. There are a variety of grants available such as one that works through state coalitions to train advocates and encourage economic independence from abusers.
