ORDER

The Board of Commissioners on Grievances and Discipline¹ filed its final report in this court on April 7, 2014, recommending that, pursuant to former Gov.Bar R. V(6)(B)(3), respondent, Jennifer Ann Gorby, be suspended from the practice of law for a period of one year with the entire suspension stayed on conditions. Relator, disciplinary counsel, filed objections to said final report, oral argument was held, and this cause was considered by the court.

On consideration thereof, it is ordered and adjudged by this court that pursuant to Gov.Bar R. V(12)(A)(3) and consistent with the opinion rendered herein, respondent, Jennifer Ann Gorby, Attorney Registration No. 0073833, last known business address in Salem, Ohio, is suspended from the practice of law for a period of one year, all stayed on the conditions that respondent engage in no further misconduct and submit to a one-year period of monitored probation focusing on law-office and trust-account management. It is further ordered that if respondent fails to comply with these conditions, the stay will be revoked and respondent will serve the full one-year suspension.

It is further ordered that on or before 30 days from the date of this order, relator shall file the name of an attorney who will monitor respondent during the probation. It is further ordered that at the end of the probationary period, relator shall file a report with this court indicating whether respondent has complied with the terms of probation, including monitoring.

It is further ordered that respondent be taxed the costs of these proceedings in the amount of \$1,082.33, which costs shall be payable to this court by cashier's check or money order on or before 90 days from the date of this order. It is further ordered that if these costs are not paid in full on or before 90 days from the date of this order, interest at the rate of 10% per annum shall accrue as of 90 days from the date of this order and the matter may be referred to the Attorney General for collection. It is further ordered that respondent is liable for all collection costs pursuant to R.C. §131.02 if the debt is certified to the Attorney General for collection. Respondent may be held in contempt and suspended until costs and all accrued interest are paid in full.

It is further ordered by the court that within 90 days of the date of this order, respondent shall reimburse any amounts that have been awarded against respondent by the Lawyer's Fund for Client Protection pursuant to Gov.Bar R. VIII(7)(F). It is further ordered by the court that if after the date of this order the Lawyer's Fund for Client Protection awards any amount against


respondent pursuant to Gov.Bar R. VIII(7)(F), respondent shall reimburse that amount to the Lawyer's Fund for Client Protection within 90 days of the notice of such award.

It is further ordered that at the end of the probationary period respondent may apply for termination of probation. It is further ordered that respondent's probation will not be terminated until (1) respondent files an application for termination of probation in accordance with Gov.Bar R. V(21)(D), (2) relator files a report with the clerk of the Supreme Court indicating that respondent has complied with the terms and conditions of probation during the probationary period, (3) respondent complies with this order and all other orders issued by this court, (4) respondent complies with the Rules for the Government of the Bar of Ohio, and (5) this court issues an order terminating respondent's probation.

It is further ordered that respondent shall keep the clerk and disciplinary counsel advised of any change of address where respondent may receive communications.

It is further ordered that service shall be deemed made on respondent by sending this order, and all other orders in this case, to respondent's last known address.

It is further ordered that the clerk of this court issue certified copies of this order as provided for in Gov.Bar R. V(17)(D)(1) and that publication be made as provided for in Gov.Bar R. V(17)(D)(2).
