



As of the time of this response by appellants Dr. Ronald Jordan and Northeast Ohio Neighborhood Health Services, Inc., the Court's docket indicates that Justices O'Connor and Lanzinger have already denied appellee's motion and decided not to recuse themselves. The Chief Justice and the remaining Justices should also deny the motion and not recuse themselves for the reasons stated in appellants' August 24, 2006 response to appellee's first motion to recuse.


