

CLAIM DETERMINATION ENTRY

In Re Application of **Belinda L. Lineburg vs. Leonard Young**
CSF Claim No. 05-0072

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this **1st day of December, 2006** on the application of **Belinda L. Lineburg** alleging a loss in the amount of \$1,600.00, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and **Leonard Young**.
- b) The claimant suffered a loss of \$1,600.00 on or about December, 2004.

The Commissioners further find that the dishonest conduct consisted of **theft of unearned/unreturned legal fees**, and that the following disciplinary proceedings were taken:

Disbarred, 4/29/05

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of **Belinda L. Lineburg** is eligible for reimbursement in the amount of **\$1,600.00**.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
