






This matter is before the Court upon the agreement between the Montgomery County Support Enforcement Agency (CSEA) and Charles A. McKinney. The parties are agreed as follows:


1. Charles A. McKinney has paid through the CSEA the sum of FIVE THOUSAND DOLLARS (\$5,000.00).
2. Charles A. McKinney shall pay through the CSEA the sum of FIVE THOUSAND DOLLARS (\$5,000.00) within thirty (30) days of this Entry.
3. Charles A. McKinney has a payroll account which is subject to a deduction notice for the purpose of child support payments. Mr. McKinney shall provide proof to the CSEA within the next thirty (30) days that the sum of FOUR THOUSAND NINE HUNDRED NINETY DOLLARS (\$4,990.00) has been deposited into the account and that sum will remain specifically be available for the purpose of three (3) months of child support, including arrearages. Further, the account will be used for ongoing child support payments.

4. Based upon the foregoing, this court finds that Defendant is subject to a withholding or deduction notice to collect current support and arrearage due under this order.


