
Enclosed is a copy of the continuing legal education record of Darrell Wendell Holland, attorney registration number 0022551, as of March 5, 2007. (Exhibit 1) A review of his record indicates that since October 14, 2005, he has reported completing eleven (11) approved CLE activities for a total of 33.75 CLE credits. Of this amount, 9.0 hours were awarded for instruction in professional conduct.

A review of Mr. Holland's entire record of continuing legal education indicates that for the 1990/1991 reporting period, Mr. Holland failed to file his final reporting transcript by the January 31, 1992, deadline, and was assessed a \$50 late filing fee. On April 13, 1992, Mr. Holland came into compliance. For the 1994/1995 reporting period, Mr. Holland failed to file his final reporting transcript by the January 31, 1996, deadline, and was assessed a \$50 late filing fee. On April 10, 1996, Mr. Holland came into compliance. The continuing legal education records indicate that Mr. Holland has been in full compliance for all other reporting periods.


