

the Court not construe the fact that he could not attend the hearing as disrespect for the Court.

CONCLUSION

For the reasons set forth, herein above, Respondent respectfully requests that this Honorable Court issue an Order as follows: (1) acknowledging that he has complied in full with item nos. one (1) and (2) of the Order; and (2) staying the issuance of an arrest warrant because it is simply impossible for him to reimburse the Fund at this time and because he will endeavor to set up a payment plan within the next thirty (30) days.
