





COGNOVIT PROMISSORY NOTE

\$27,892.61

March 28, 2007

FOR VALUE RECEIVED, the undersigned promises to pay to the order of THE CLIENTS' SECURITY FUND OF OHIO at the Ohio Judicial Center, Columbus, Ohio 43215, or at such other address as the holder hereof may from time to time designate in writing, the principal sum of Twenty Seven Thousand Eight Hundred Ninety Two and 61/100 (\$27,892.61).

The principal sum shall be due and payable in equal monthly installments of One Hundred and 00/100 Dollars (\$100.00) each, beginning April 15, 2007 and continuing thereafter until said principal sum shall have been paid in full. All or any part of the principal sum may be pre-paid at any time without penalty.

Upon default in payment of any installment within ten (10) calendar days after the same is due, this note shall, at the option of the holder hereof, bear interest thereafter at the rate of ten percent (10%) per annum, and the entire principal remaining unpaid, together with accrued interest, shall, at said holder's option, become immediately due and payable without notice or demand.

All persons now or hereafter liable for the payment of the principal and interest due on this note, or any part thereof, do hereby expressly waive presentment for payment, notice of dishonor, protest and notice of protest, and agree that the time of payment or payments of any part of this notice may be extended without releasing or otherwise affecting their liability on this note.

The undersigned hereby authorizes any attorney at law to appear in any court of record in any county in the State of Ohio, or elsewhere, where the undersigned resides or signed this note, after the obligation evidenced hereby, or any part thereof, becomes due and is unpaid, and waive the issuance and service of process, and confess judgment against the undersigned in favor of the holder of this note for amount then appearing due, together with the costs of suit, and thereupon to release all errors and waive all right of appeal and stay of execution, but no judgment or judgments against the undersigned shall be a bar to any subsequent judgment against those of the undersigned against whom judgment has not been taken.
