




On behalf of the Certified Grievance Committee of the Akron Bar Association, I would like to thank you for agreeing to serve as the monitoring attorney for Attorney Julius P. Amourgis during his 12 month probationary period imposed by the Ohio Supreme Court.

I have enclosed a copy of my letter to Attorney Amourgis, a copy of the Supreme Court decision of March 21, 2007, Akron Bar Association vs. Amourgis, 113 Ohio St.3d, 32, and a copy of Gov. Bar Rule V Section 9. Section B defines your duty to monitor his compliance with the Supreme Court order, file a quarterly report with the relator (Certified Grievance Committee of the Akron Bar Association), and report any violations.

Section C requires Attorney Amourgis to personally meet with you once a month, sign waivers if necessary and fully cooperate with you.

Thank you on behalf of the Akron Bar Association for agreeing to serve in this role and if you cannot complete the year please advise and I will appoint a substitute. It might be a good idea at some point, if all goes well, at or near the end of the probation period to have you come to one of our Grievance meetings and fill us in on how he is doing.
