


**APPELLANT THE CHILLICOTHE TELEPHONE COMPANY'S  
NOTICE REGARDING STATUS OF RELATED PROCEEDINGS**

On October 10, 2006, the Court stayed proceedings in this case, at the request of the Appellant, The Chillicothe Telephone Company ("Appellant" or "Chillicothe"), pending the conclusion of related proceedings at the Public Utilities Commission of Ohio. By its Entry of June 26, 2007, the Court ordered Appellant to file a notice advising the Court of the status of the related proceeding within 15 days of that Entry.

For its notice regarding the status of the related proceedings, Appellant can report to the Court that the other party to the related proceedings, which had initiated those proceedings, recently abandoned its efforts to complete them. As a result, the related proceedings are no longer pending. Accordingly, Chillicothe has decided not to pursue the issues it raised in its appeal through this appeal. Chillicothe commits to promptly making a filing with the Court to dismiss its appeal.


