


COUNSEL FOR RESPONDENTS



Respondents notify the Court that they have complied with the Court's order of August 15, 2007. On October 11, 2007 the City made back pay checks available to the individually named Relators, delivered post judgment interest checks to the Relators' lawyer, and delivered a check containing the attorney's fees deducted from pay checks as authorized by the Relators to the Relators' lawyer. The City has prepared back pay checks for the two deceased individually named Relators and has prepared a check for the lawyer representing legal fees, but has not released these two checks because the lawyer for the two deceased Relators has not provided documents showing who has authority to authorize the City to deduct the legal fees. The City delivered the post judgment interest check for these two deceased Relators to the Relators' lawyer on October 11, 2007.


