

NOW COMES the Appellee, Regina Harris, as Guardian for the Estate of Walter Hollins, and moves for an order from the Ohio Supreme Court for a settlement conference pursuant to Supreme Court Rule XIV Section 6. In support of this motion, Appellee states as follows:


That the high court should order a settlement conference would seem axiomatic. In urban areas, at least, the resources of the Ohio judicial system appear strained to the breaking point. The number of judicial and court administrative man hours devoted to this case alone over the past ten years by judges, staff attorneys, law clerks, secretaries and court administrative personnel has been astronomical. To resolve this case once and for all without another multi-week trial and ensuing years of appeals, would serve judicial economy.

In Appellants' Response to Appellee's Motion for Reconsideration and Motion for Stay Pending Petition for Certiorari to the United States Supreme Court the Appellants repeatedly express concern that the facts giving rise to this case occurred more than 20 years ago and therefore they have apprehension about further delay in resolving this case. Assuming this is a sincere concern, a few weeks – here or there – in a ten-year litigation certainly could not be prejudicial to the corporate defendants who are simply earning interest on their insurance reserves.

WHEREFORE, Appellee prays for an order requiring the parties to attend a settlement conference in this case.


