

ORDER

It appearing to the Court that on September 27, 2007, an Order was entered in this proceeding directing Respondent to show cause within 30 days why this Court should not impose identical discipline as heretofore imposed by the Supreme Court of Ohio; and that notice was mailed to the respondent at his last known address, by certified mail, and posted to this Court's official website, and no response having been filed with the Clerk of this Court;

IT IS THEREFORE ORDERED that Respondent be suspended for a period of two years, with the entire two years stayed, from the practice of law in this Court, pursuant to Rule II E of the Model Federal Rules of Disciplinary Enforcement adopted by this Court on February 1, 1979. If Respondent fails to comply with the conditions set forth in the Order entered on September 20, 2007 by The Supreme Court of Ohio, the stay will be lifted and respondent will serve the entire two-year suspension.

IT IS FURTHER ORDERED that the Clerk of this Court issue certified copies of this Order to the Disciplinary Counsel of the Supreme Court of Ohio, to the Clerks of the Supreme Court of the United States and the United States Court of Appeals for the Sixth Circuit, to the National Discipline Data Bank and to its Divisional Offices.
