

BOARD OF COMMISSIONERS ON GRIEVANCE AND DISCIPLINE**


Respondent, Jay Alan Goldblatt, by and through undersigned counsel moves this honorable Court for a ten (10) day extension of time to file his Objections of Respondent to Final Report of the Board of Commissioners on Grievance and Discipline (Objection).

As Grounds for this Motion, Respondent states the Order to Show Cause was issued by the Court on November 2, 2007 and a response due on November 26, 2007. The Respondent filed the Objection in a timely manner by sending the original plus twelve (12) copies via United States Express Mail pursuant to Ohio Supreme Court Rule VIII(A)(11) which states that "any other pleadings, memorandum, motion or document" required twelve (12) copies plus the original to be filed with the Court.. The Objection

was received in a timely manner by the Court on November 26, 2007, however, the Objection was rejected pursuant to Ohio Supreme Court Rule VIII, Section 5(A)(4) which states that an original action must be filed by sending the original plus eighteen (18) copies to the Court. The Respondent requests and extension of 10 days in order to get the necessary eighteen copies to the Court. This leave is necessary because Respondent and Respondent's representation are located in Cleveland, Ohio and therefore cannot get additional copies to the Court this afternoon.
