




Bryan Bright Johnson filed an Application for Reinstatement with this Court on November 19, 2007. Mr. Johnson was suspended from the practice of law on May 16, 2007, for a period of one year with the final six months stayed and six months probation with conditions. See, *Disciplinary Counsel v. Johnson*, 113 Ohio St.3d 344, 2007-Ohio-2074.

Gov.Bar R. V(10)(A) permits an Application for Reinstatement at the expiration of the period of suspension, provided, among other things, there are no formal disciplinary proceedings currently pending against the applicant. The purpose of this letter is to request written verification that there are no formal disciplinary proceedings pending against Mr. Johnson before the Board of Commissioners on Grievances and Discipline.
