

**MOTION TO ADMIT BENJAMIN C. MIZER *PRO HAC VICE*  
TO REPRESENT APPELLANTS ADMINISTRATOR, OHIO BUREAU  
OF WORKERS' COMPENSATION AND STATE OF OHIO**

In accordance with Supreme Court Practice Rule I, Section 2, Stephen P. Carney (Ohio Bar No. 0063460) moves the Court to admit Benjamin C. Mizer to appear on behalf of and represent *pro hac vice* Appellants Administrator, Ohio Bureau of Workers' Compensation and State of Ohio in this case, stating the following grounds:


