


**RELATOR'S NOTICE OF APPOINTMENT
OF MONITORING ATTORNEY**

By order filed May 16, 2007, the Supreme Court of Ohio suspended Respondent Bryan B. Johnson, from the practice of law in the State of Ohio for one year with six months of the suspension stayed.
