


CLAIM DETERMINATION ENTRY

In Re Application of Donna K. Burton vs. Pippa Lynn Henderson
Claim Number 06-0099

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 7th of December, 2007 on the application of Donna K. Burton alleging a loss in the amount of \$1,100.00, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Pippa Lynn Henderson.
- b) The claimant suffered a loss of \$1,100.00 on or about August 27, 2004.

The Commissioners further find that the dishonest conduct consisted of unearned fees, and that the following disciplinary proceedings were taken:

DISBARRED on 4/5/2006

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Donna K. Burton is eligible for reimbursement in the amount of \$1,100.00.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
