

I, CARL G. MCMAHON, being first duly sworn, deposes and states as follows:

1. Affiant's Affidavit is made based upon his personal knowledge of the matters recounted in this Affidavit.

2. Affiant is competent to testify and Affiant is not suffering from any emotional, psychological, nor legal disabilities which would interfere with the accuracy of this Affidavit.

3. Affiant states he is the applicant for reinstatement in this case and pursuant to Government Bar Rule 5, Section 10(A), he is applying for reinstatement to the practice of law

in the state of Ohio from the Court's suspension order issued on July 25, 2007.

4. Affiant states that he has complied with the Continuing Legal Education requirements of Government Bar Rule X, Section 3(G) having taken more than the required one hour Professionalism CLE and more than the required six (6) hours of Continuing Legal Education requirements which may be verified through the Court's CLE Division records.

5. Affiant states that no formal disciplinary proceedings other than the one in this case are pending against him to his knowledge as may be verified through the Cleveland Bar Association and The Supreme Court's Disciplinary Counsel.

6. Affiant states that he has complied with the six (6) month Order of Suspension by the Ohio Supreme Court.

7. Affiant states that he had timely paid One Thousand Two Hundred Thirty Nine Dollars and Fifty-Five Cents (\$1,239.55) for the costs of this proceeding that have been assessed against him thus far as required by the Order of Suspension as may be verified through the Supreme Court's Clerk of Court's Office.

8. Affiant states that there are no funds due from him to the Client Security Fund since no harm ever befell the client in this case. No amounts were awarded against the Respondent by the Client Security Fund since the client never filed a grievance against Respondent. No restitution was ever ordered

in this case. This may be verified through the Client Security Fund.


9. Respondent respectfully apologizes for the unethical conduct set forth in this grievance proceedings and hopes to earn reinstatement to the practice law in Ohio.
