This is in response to your letter dated, March 3, 2008, regarding Derek A. Farmer.

On March 2, 2007, the Clients' Security Fund (CSF) Board of Commissioners awarded \$7,915.00 to one of Mr. Farmer's former clients (Claim No. 03-2003, Charles J. Martin/Teresa Smith). On February 15, 2008, Mr. Farmer made full restitution to the Clients' Security Fund in the amount of \$7,915.00.

On February 19, 2008, Mr. Farmer delivered a \$4,000 check to the CSF and requested that it be forwarded to another former client to satisfy a pending CSF application for reimbursement (see attachments). The check has been forwarded and the CSF claim has been closed.

The CSF does not have any additional outstanding claims involving Mr. Farmer, and no additional restitution is owed to the CSF. This information may be released to the public.




