

AFFIDAVIT BY YVETTE BARBARA BALDWIN

My name is Yvette Barbara Baldwin. I am a single female parent of 2 young adult daughters. I presently reside alone at 688 Riddle Road, apt# 1000E, in Cincinnati, Ohio 45220. I'm currently employed by the Hamilton County Clerk of Courts, in the Common Pleas Felony criminal division, located at 1000 Main Street, Cincinnati, Ohio 45202. I'm requesting the assistance of the Supreme Court of Ohio; with an international issue of significant importance. I am concerned for my personal safety. I have received death threats. I have been informed through hearsay that there is a plot/scheme to have me murdered before the end of May 2008. The reasoning behind the death threats is based on 2 international edicts that I have on file at the Cincinnati bar Association. The edicts are from Greece/England. The edicts have been on file in my name since I was a young girl. I have learned through hearsay that my identity was also used for various people to be given authorization to sign and pickup international mail that may have been sent in my name. The international mail was reportedly picked up at the local post offices in Cincinnati, Ohio, without my knowledge; for over 30 years. To explain how the crimes against me and violation of my civil rights came about, I have to give a brief explanation of the events that occurred over 40 years ago. I attended Schiel Elementary School located at 2821 Vine Street, in Cincinnati, Ohio. My homeroom teacher was Mrs. Hardy. During my 5th grade school year, Greece sent Greek officials to my elementary school for a movie production/documentary that I was needed to play an important role in. In addition I was presented with a financial award of enormous wealth. (Over a Billion dollars) The award was presented to me by Mr. Onassis. My award, file and legal documents were kept on file in the main office of the Schiel Elementary School; I was advised by the school officials that the legal documents, award letter and film would be at the school for me to pickup at least until I was 59 years of age. I was further advised to give Mr. Onassis's name when I came in for my international historical film, award and documents. In my early twenties I had 2 children; 2 daughters approximately 2 years apart. My children attended pre-school in the City of Wyoming school district. During this time my mother suggested that I stop in at the Schiel Elementary school to check on the award. This would

have been around winter-spring of 1985. I had just recently received recognition for using American Red Cross skills to assist a mother with saving her baby's life (The baby had stopped breathing) At the time I was employed by the Wyoming Police Department as a police, fire, and Life squad dispatcher. Greek officials contacted the Police Chief, Robert Hess with my legal documents (EDICTS) and requested that he inform me that Greece wanted me to help run the country of Greece. Police Chief Robert Hess further advised that it was considered best that I wait until my children were adults. I checked with my parents who also advised that I would have to wait until my daughters were adults. Due to important life commitments, my parents were not able to keep my children during the time I would be traveling in and out of the country. I stopped by Schiel Elementary School as previously mentioned between winter and spring of 1985; the office clerk advised me that Greece had left a letter on file for me. I told her that I was aware that the letter was on file with Schiel Elementary school; I further advised the school office clerk that I would be back when my children were raised as adults. On Wednesday, April 16th, 2008 at approximately 1:50 p.m., I arrived at Schiel Elementary school at 2831 Vine Street. I walked in the main office of the school to inquire about my documents and file. There were 2 ladies sitting in the main office that I spoke directly with. 1 of the female office workers advised that she has been an employee at the school for approximately 5 years, the second female office worker advised that she has been an employee for less than 2 years; both women advised me that they had no knowledge of the legal documents, award letter or film left at the school. I was then referred to the school's principal, Mr. Lewis; again I explained my reason for being at the Schiel Elementary school. Mr. Lewis said that he had no knowledge of the legal documents, award letter, and film. I became very concerned and advised Mr. Lewis that I would need to use his phone to make a police report. Obviously I was very upset; remaining calm, I called 911 explaining that this call was regarding an international matter and that I needed the police to respond to the school. The 911 operator listened intently to my problem and referred me to the Cincinnati Police offense reporting line at Tele# 513-263-8160. Cincinnati Police Officer Pruitt answered the police offense reporting line;

patiently taking a detailed report; advising that the report would be referred to the investigators for further review. I then contacted the local FBI office, speaking briefly to Agent Remley; Agent Remley Referred/transferred me to the FBI law team. I left a detailed message. As I was preparing to leave, Cincinnati Police Officers arrived at the school. 2 of the officers, Officer Palmassano and Officer Kreider listened as I spoke with Officer Punn (?). Officer Punn (?) referred me to the public school officials that keep documents offsite, he then advised me that Principal Lewis wanted me to leave. I left the school quietly and orderly. I was raped in 1994; during the time that I resided in Marietta, Georgia, my apartment was broken into while I slept. I was drugged by some men that shot me in the top muscle of my left arm. I later learned through hearsay that the drug used was some form of a horse tranquilizer; I was left for dead. I received death threats prior to and after the rape. I had no way of knowing that the rape and death threats were linked to my international legal documents and Award letter. I am very concerned with the fact that I have several billions of dollars in my name attached to United States accounts, but whenever I apply for credit I'm immediately turned down. I receive death threats against my life on a regular basis; for example, I can be walking downtown Cincinnati, at a store, or riding a bus when I'm advised of a death threat against me or my children. The last 3 letters that I received certified from Greece in Indianapolis advised me that my account was over 4 billion dollars and that my edict(s) status was intact. I'm requesting that the Ohio Supreme Court investigate Joyce Darlene Hyde aka: Seymour for conspiracy to commit murder against me. I have learned through hearsay that Joyce Darlene Hyde aka; Seymour has been identified as 1 of the person(s) involved in a murder plot/scheme against me. Joyce was a former classmate/acquaintance friend that I befriended for a time. I received so many warnings about Joyce being a problem for me that I discontinued the friendship. In addition I'm requesting that the Ohio Supreme Court investigate a female black by the first name of Johnetta. Johnetta worked as a nurse's aide or clerk at Christ Hospital around the time I had an outpatient surgery in 2002. I have also learned through hearsay

that Johnetta has been in on several plots to destroy my identity and to illegally use edicts that I have On file at the Cincinnati Bar Association. In addition, I'm requesting that the Ohio Supreme court investigate Grant Hill of the NBA and his wife Tamia. I was also informed that Grant Hill and his wife Tamia have attempted to use my identity and gain access to my edicts and financial award. According to various versions of hearsay I have learned that Tamia has identified herself as the Queen of Greece at various functions throughout the United States; using my royal edicts as her authorization. There are several names that I have been advised of in the overall scheme/plot to destroy my name and take my award, edicts; and take my life. At this time I do not have enough detailed information to list any additional names. As stated earlier in my complaint I work for the Hamilton County Common Pleas Felony Criminal division. I help process cases for murders, rapes, manslaughters, assaults and various type of evil criminal activity against citizen's every day. People with kill for a penny in a card game. I shouldn't have to speak on what would happen to a person or their family lines for billions.
