

By order filed November 1, 2006, the Supreme Court of Ohio suspended respondent, Derek A. Farmer, from the practice of law in the state of Ohio for two years with one year stayed on conditions. The court ordered that respondent be placed on probation following his reinstatement and that during his period of probation, respondent was to be monitored by an attorney. On May 6, 2008, the court ordered the appointment of alternate relator, Disciplinary Counsel. Pursuant to that order, Disciplinary Counsel is required to appoint a monitor to supervise respondent during the period of his probation.

Now comes alternate relator, Disciplinary Counsel, and hereby notifies this court that John W. Waddy, Jr., of Columbus, Ohio, Attorney Registration Number 0009562, has agreed to monitor respondent during the period of his probation. At the conclusion of respondent's

probation, as ordered, alternate relator will file a report indicating whether respondent has complied with the conditions of the probation and monitoring by relator.


