

## Affidavit of Compliance

Jay Alan Goldblatt deposes and says as follows:


1. I am the person named as Respondent in the Supreme Court matter captioned Disciplinary Counsel, Relator v. Jay Alan Goldblatt, Respondent, Case No. 07-1961. This Affidavit of Compliance is given pursuant to Court's Order filed May 29, 2008 in such matter.
2. From February 1, 1987 until November 9, 2005, I was employed on a salaried basis as an in-house legal counsel to a corporate enterprise.
3. As of November 9, 2005, that corporate enterprise was the only client being represented by me; none of the matters for which I was providing representation at that time involved pending litigation matters.
4. On November 9, 2005, my employment with that client ended as did my representation of that client in all legal matters.
5. On November 11, 2005, pursuant to order of the Honorable Janet Burnside, Cuyahoga County Court of Common Pleas, I wrote to the Attorney Registration Section of the Ohio Supreme Court and asked to be granted Inactive Status

effective immediately.


6. At that time, the only client I had been representing was such corporate enterprise with whom I had been employed. A copy of the letter that I delivered to such corporation informing it of my Inactive Status was attached as an Exhibit to the Affidavit that I filed with the Court after my Interim Suspension in case number 05-2332.
7. I was not representing that or any other client in any pending litigation, so I made no notice to any opposing counsel.
8. Since November 2005, continuing through the January 27, 2006 filing of the Order in Case No. 05-2332 and continuing through the date hereof, I have not engaged in the practice of law in any form.
9. As a consequence of the foregoing, I have no pending legal matters, no fees or expenses paid in advance that are unearned or not paid, no trust money or property in my possession or control and no papers or property pertaining to any client, and there are no clients, co-counsel or opposing counsel that I need to inform of the Court's Order filed May 29, 2008 in this Case.
10. Therefore, there are no Notices that I have given or am required to give by the Court's Order filed May 29, 2008 in this Case.

11. I have never been ordered to reimburse any amounts that have been awarded by the Clients' Security Fund pursuant to Gov.Bar R VIII(7)(F).
