


**RICHARD E. JOSEPH'S MOTION TO VACATE THE

MEMORANDUM IN SUPPORT

On July 9, 2008, this Court accepted review of Mr. Joseph's case, both as a certified conflict and a discretionary appeal. *State v. Joseph*, 118 Ohio St.3d 1505, 2008-Ohio-3369. On July 9, 2008, this Court ordered that the Clerk of the Allen County Court of Appeals transmit the record by July 29, 2008. (July 9, 2008 Order to Certify Record).

Due to the fact that Mr. Joseph's record is voluminous, the Allen County Clerk of Courts was unable to comply with the order of this Court. (See Exhibit B, Peggy L. Caskey's Affidavit, attached). However, personnel at the Allen County Clerk's Office mistakenly went to the visiting trial judge assigned to the case and obtained an extension of time to comply with this Court's order. (See Exhibit A, Allen County Court of Common Pleas Order, attached).

While the rules of this Court are silent as to whether extensions may be obtained to file the record in cases not involving the death penalty, only this Court may grant extensions to file the record in capital cases. See S. Ct. Prac. R. XIX, Section 4(C). As such, if extensions may be obtained, only this Court has the authority to modify one of its prior orders to transfer the record. Once this Court either grants a motion for leave to appeal or to certify the record, a lower court is precluded from exercising jurisdiction. See *State v. Murphy* (1990), 49 Ohio St.3d 293, 295 (citing Section 2(B), Article IV of the Ohio Constitution). In this case, this Court had done both, as it granted Mr. Joseph's motions to appeal and certify the record. Consequently, the trial court lacked the authority to overrule the July 9, 2008 order of this Court, regarding the date as to when the record was to be filed.


Accordingly, Mr. Joseph requests that this Court vacate the July 29, 2008 order of the trial court. Mr. Joseph further requests that this Court permit the Allen County Clerk of Courts

to transmit Mr. Joseph's record on or before September 29, 2008. (See Exhibit B, Peggy L. Caskey's Affidavit, attached).






