



The undersigned, being first duly sworn and cautioned, states that he has personal knowledge of the facts in this Affidavit and is competent to testify regarding same.

Affiant states as follows:

1. I am Lawrence Edward Winkfield, attorney at law, who was indefinitely suspended from the practice of law in Ohio on January 21, 2006.
2. My current personal residence address and the address where I may receive all communications is 400 Sweetgum Way, Westerville, Ohio 43081.
3. I ceased and desisted from the practice of law in the State of Ohio and/or in any other State since before December 31, 2002.
4. In compliance with the decision and Order of this Court, dated January 11, 2006, I had no clients at all and therefore had no clients

to whom to send certified mail notices of my indefinite suspension from the practice of law.

5. In compliance with the decision and Order of this Court, dated January 11, 2006, I have not represented or given legal advice to any client whatsoever, and therefore had no client with pending legal matters to whom it was necessary to send notices of my indefinite suspension from the practice of law.
6. Likewise, it was not necessary for me to ask any Municipal, Common Pleas or Federal Court to appoint other attorneys to substitute in my place or to grant any client time to procure other representation.
7. Likewise, there are not and were not any fees or expenses paid in advance that are unearned or not paid pertaining to these matters. There is no trust money or property in my possession or control and I have not maintained a trust account since late 2002.
8. Likewise, there were no papers or other property pertaining to any pending matters presently in my possession which were to be delivered to any client.
9. Likewise, based upon paragraphs 3 – 8 above, I did not have, nor do I have now any correspondence showing proof of service by certified mail to any client, opposing party or opposing counsel.
10. There are no disciplinary proceedings pending against me with any certified grievance committee or with the Office of Disciplinary Counsel.
11. I have complied with the continuing legal education requirements of Gov. Bar R. X, (3)(G) and Gov. Bar.R. X(3)(A)(1), for each six months, or portion of six months, of the suspension.
12. I have paid all cost of proceeding as ordered by the Court and I owe no money of reimbursement to the Clients' Security Fund pursuant to Gov.Bar R. VII(7)(F).

13. Apart from the matters address in the Motion to Vacate the Court's Contempt Order, I have otherwise complied with the Order of Suspension.

14. Based on the foregoing, and for the reasons outlined in my Motion to Vacate the Contempt Order, I request that my license to practice law be reinstated.
