
Now comes Relator, the Columbus Bar Association (the “CBA”), through Counsel, Joyce D. Edelman, and requests a ten (10) day extension of time to file Objections to the Final Report of the Board of the Unauthorized Practice of Law of the Supreme Court of Ohio (“Objections”) and a Brief in Support thereof pursuant to the Rules of Practice of the Supreme Court of Ohio, Rule XIV, § 3(B)(2)(b). The CBA received a copy of Entity Respondents’ Request For Extension of Time to File Respondents’ Objections and Supporting Brief (“Entity Respondents’ Request”) on September 26, 2008 filed on behalf of American Family Prepaid Legal Corporation, Heritage Marketing and Insurance Services, Inc., and Jeffrey Norman.¹

While Entity Respondents’ Request has not yet appeared on the Court’s online docket, the CBA would like to advise the Court that the CBA also intends to file Objections and a Brief in Support thereof. The Court should grant the CBA’s Request for Extension of Time to File Objections and a Brief in Support thereof because it would be patently unfair for the CBA and Entity Respondents to not file simultaneous objections. Therefore, if the Court grants Entity


