





CLAIM DETERMINATION ENTRY

In Re Application of Rik Robert Roby and Robin Lynn Dunn vs. Gregg Devere Hickman
Claim Number 07-0020

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 5th of September, 2008 on the application of Rik Robert Roby and Robin Lynn Dunn alleging a loss in the amount of \$1,500.00, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Gregg Devere Hickman.
- b) The claimant suffered a loss of \$1,500.00 on or about July or August, 2006.

The Commissioners further find that the dishonest conduct consisted of unearned fees, and that the following disciplinary proceedings were taken:

DISBARRED on 8/6/2008


The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.


