**MOTION OF INDIVIDUAL RESPONDENT CHRIS MILLER FOR LEAVE TO
SUPPLEMENT THE RECORD TO CLARIFY STATEMENTS MADE RECENTLY
BY RELATOR COLUMBUS BAR ASSOCIATION**

As a pro se respondent in this case, the recent request for leave filed by the Columbus Bar Association concerns me and I wish to make a clarification to this court. In the filing, attorney Edelman characterizes the operations of AFLP, Heritage and Quest as ongoing. I cannot speak to the validity of these statements as I have not been employed by, nor run appointments for AFLP, Heritage or Quest since early 2007. I believe that it is important for the court to realize that I and, as far as I know, the majority of the agents who worked for these companies have not run any appointments for the Entity Respondents or Quest since approximately May of 2007. If any of these companies are still doing business in Ohio, they are doing it with new agents I would presume.

I believe that the panel recognized this fact along with the fact that the agents for both AFLP and Heritage were simply operating at the direction of the Companies when going about their daily work. This is obviously why the panel recommended (as it should have), no penalties for the majority of individual respondents.

In summary, attorney Edelman's recent filing makes it seem that the companies continue to operate as they always have with the agents still running appointments. I simply want the court to know that I am not working for any of these companies and have absolutely no plans to work for any company similar to AFLP in the future.




