



MERIT BRIEFS**

The Office of the Ohio Consumers' Counsel, Ohio Partners for Affordable Energy, the Public Utilities Commission of Ohio and Duke Energy Ohio, Inc., jointly stipulate that the time within which the Office of the Ohio Consumers' Counsel and Ohio Partners for Affordable Energy may file their Merit Briefs is extended from the original filing due date of November 24, 2008 to December 14, 2008. Pursuant to S.Ct.Prac.R. 




