
Dear Ms. Grosko:

This is in response to your January 7, 2009 letter regarding whether Julius P. Amourgis, (attorney registration number 0069140) is in compliance with provision of Rule X.

On December 5, 2008, Mr. Amourgis was sanctioned by the Commission on Continuing Legal Education for failure to complete the 24 hour requirement for the 2006-2007 reporting period. 

