
## APPLICATION FOR REINSTATEMENT

1. By this Court's Order dated August 14, 2008, Applicant was suspended from the practice of law for a period of one year with the last six months stayed on conditions that Respondent (1) consult with the Ohio Lawyers Assistance Program, enter into an OLAP contract to obtain whatever disability or dependency assistance he needs, and comply with all terms for the duration of the contract; and (2) upon reinstatement be placed on monitored probation for one year.
