


RESPONDENT'S RESPONSE TO NOTICE FROM CLE COMMISSION

Now comes Respondent, Thomas Joel Manning, and does hereby submit his response to the notice from the CLE Commission filed with the Court on or about June 4, 2009.

The CLE Commission's notice indicates that, as of June 2, 2009, Respondent has taken 14.5 CLE credit hours, with 3.5 of those hours related to professional conduct. However, as indicated by Respondent in his petition for reinstatement, most of his CLE hours accrued were just recently taken, and are still in the process of being reported to the CLE Commission. In fact, Respondent's online CLE transcript, which is accessed through the Court's website, indicates that Respondent has 20.5 hours, with 7.0 of those hours related to professional conduct. Copies of the transcripts showing those hours are attached as Exhibit 1.

Further, Respondent has also taken the following hours, which have yet to show up on his online transcript:



Respondent also attaches copies of the receipt from the Cincinnati Bar Association and credit summary from the Dayton Bar Association in further support of the above as Exhibits 2 and 3.

Respondent should be therefore be credited with a total of 43.5 CLE hours accrued since his initial suspension date of 11/22/2006, with 12.0 of those hours related to professional conduct. Pursuant to Gov. Bar R. X(3)(G), Respondent was ordered to complete one hour of CLE for each month of his suspension, with one credit hour of CLE related to professional conduct for each six month period of his suspension. Respondent would therefore be responsible for taking 30 hours of CLE credits, with 5 of those hours related to professional conduct. As shown above, Respondent is in full compliance with the Court's order and Gov. Bar R. X(3)(G).

As such, as requested in his initial petition for reinstatement, Respondent asks this Court to reinstate him to the practice of law.




