

**Motion of Appellee Raynell Robinson to Reschedule Oral Argument,  
Appoint Counsel, and to Set a Deadline for Appellee to file a Jurisdictional  
Memorandum and/or a Merit Brief**

Appellee asks this Court to supplement the record with the presentence investigation report, which is in the custody of the trial court. S.Ct.Prac.R. V, §7. At the sentencing hearing, the trial court stated that it was relying on the report. T.p. (sentencing) p. 8. Even though this is an appeal of a legal issue, the presentence investigation report frequently reports facts relevant to the facts of a case, and the report would likely give this court and counsel a more complete account of the events surrounding this case. Further, the report should have been made part of the record under S.Ct.Prac.R. V, §1, emphasis supplied:

In all appeals, the record on appeal shall consist of the original papers and exhibits to those papers; the transcript of proceedings and exhibits, along with an electronic version of the transcript, if available; and certified copies of the journal entries and the docket prepared by the clerk of the court or other custodian of the original papers. Where applicable, the record on appeal shall consist of all of the above items from both the court of appeals and the trial court.


Counsel asks for expedited consideration of this motion because Appellee's brief is currently due on July 1, 2009. This motion is filed timely because Appellee files this motion only 11 days after this Court granted Appellee leave to file a brief.

According to local counsel and the trial court's staff, the trial court secures presentence investigation reports in a vault in the trial judge's chambers.

The report will be filed under seal, so Appellee asks that this Court order that counsel for either party be permitted to review the report while it is in the custody of this Court's Clerk.


