



**STIPULATION**

Pursuant to Rule XIV, § 3(B)(2)(a), of the Rules of Practice of the Supreme Court of Ohio, David Alden, counsel for appellant Douglas Prade, and Richard Kasay, Assistant Summit County Prosecutor (Appellate Division), counsel for the State of Ohio, agreed to a stipulated 20-day extension of time for appellant Douglas Prade to file his merit brief. 
