

**MOTION TO ADMIT DAVID M. LIEBERMAN *PRO HAC VICE* TO REPRESENT
AMICUS CURIAE OHIO ATTORNEY GENERAL RICHARD CORDRAY**

In accordance with Supreme Court Practice Rule I, Section 2, Alexandra T. Schimmer moves the Court to admit David M. Lieberman to appear on behalf of and represent *pro hac vice Amicus Curiae* Ohio Attorney General Richard Cordray in the above-captioned matter, stating the following grounds:

1. Mr. Lieberman is a Deputy Solicitor in Ohio Attorney General Richard Cordray's Office, located at 30 East Broad Street, 17th Floor, Columbus, Ohio 43215.
2. Mr. Lieberman was the 2008-2009 Simon B. Karas Fellow. He was appointed as a permanent Deputy Solicitor on August 31, 2009.
3. Mr. Lieberman graduated from the Stanford Law School in 2006.
4. Mr. Lieberman is admitted to the bar of the Commonwealth of Virginia. He is also admitted to practice in the United States District Court for the Eastern District of Virginia and the United States Courts of Appeals for the Fourth, Sixth, and Ninth Circuits. 
