The Ohio Energy Group (“OEG”) a non-profit entity organized to represent the interests of large industrial and commercial customers in electric and gas regulatory proceedings before the Commission respectfully applies to this Honorable Court for leave to intervene in this case as a party Appellee. Appellants Columbus Southern Power Company and Ohio Power Company filed their Notice of Appeal on November 12, 2009 alleging that the Public Utilities Commission of Ohio (“Commission”) erred in its July 15, 2009 Opinion and Order and in its September 15, 2009 Entry on Rehearing in Commission Case No. 09-119-EL-AEC resulting in a final order that is unlawful and unreasonable.
