

THE OFFICE OF THE OHIO CONSUMERS' COUNSEL**


Pursuant to S. Ct. Prac. R. XIV Sec. 3(B)(2)(b), Appellant Office of the Ohio Consumers' Counsel ("OCC") respectfully requests a ten-day extension of time to file its Reply Brief in the above-captioned case. The OCC has not previously requested an extension of time in this case.

Good cause exists for the extension of time. The OCC's counsel requires additional time to prepare the Reply Brief due to the press of late-year regulatory work before the Public Utilities Commission of Ohio.


