



CLAIM DETERMINATION ENTRY

In Re Application of Angela Wilson vs. Patrick Peter Leneghan
Claim Number 08-0044

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 4th day of December, 2009 on the application of Angela Wilson alleging a loss in the amount of \$3,000, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Patrick Peter Leneghan.
- b) The claimant suffered a loss of \$3,000 on or about July 24, 2006.

The Commissioners further find that the dishonest conduct consisted of theft of unearned fees, and that the following disciplinary proceedings were taken:

Publicly Reprimanded on 2/14/2008

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Angela Wilson is eligible for reimbursement in the amount of \$3,000.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
