
Pursuant to Rule 14.1 Ohio Rules of Practice ,now come the counsel for Respondent Douglas Maher and counsel for the Relator Akron Bar Association and respectfully move the Court to release the respondent from custody on Sunday, February 21, 2010. At that time Respondent will have served five days of the 20 day sentence for contempt imposed by this Court. This Court further ruled that if the Respondent would cooperate with the Relator in the disposition of his files and any other pending matters the Court would consider 15 days of the sentence purged. Respondent has cooperated with the Relator prior to his incarceration and has been incarcerated since 7:30AM on February 17, 2010.Counsel jointly asks that he be released on Sunday February 21, 2010 which would constitute



5 days and that the remainder of his 20 day sentence be suspended pending his future cooperation with the Akron Bar Association with the understanding that the remainder of that sentence would be imposed if his cooperation did not continue. WHEREFORE the parties respectfully ask the Court to issue an immediate order prior to the end of business Friday, February 19, 2010 releasing Douglas Maher from custody of the Summit County Sheriff as of **Sunday February 21, 2010**

WHEREFORE, Defendant and counsel prevail upon the Court to grant the Motion.




