## **SECOND MOTION TO SUPPLEMENT THE STATEMENT OF COSTS**


The Board on the Unauthorized Practice of Law (“Board”) hereby moves the Court to supplement the Statements of Costs filed as “Exhibit 2” with the Board’s Final Report on August 26, 2008, and as “Exhibit 3” with the Board’s Motion to Supplement the Statement of Costs on October 21, 2009. Gov.Bar R. VII(7)(G) requires the Board to file an itemized statement of costs with every final report. An itemized Supplement to the Statement of Costs is attached as “Exhibit 4.” This second Supplement to the Statement of Costs assigns an additional \$6,620.51 in direct costs to the present case.

Under Gov.Bar R. VII(9)(A), bar associations “may be reimbursed for direct expenses incurred” while acting as the relator in unauthorized practice of law (“UPL”) prosecutions. In addition, bar associations may apply to the Board annually for partial reimbursement of indirect expenses associated with the investigation and prosecution of UPL cases. On February 1, 2010, Relator submitted its 2009 Certification of Annual Expenses, a report required by Gov.Bar R. VII(9). In the 2009 Certification of Annual Expenses, Relator requested reimbursement for \$6,208.40 in direct costs in this case. Also, on February 11, 2010, Relator notified the Board of an additional \$412.11 in direct costs in this case. Relator incurred these costs in January 2009, May 2009, and February 2010. Because Relator did not notify the Board of the additional costs until February 1, 2010 and February 11, 2010, the Board was not aware of these costs at the time of filing of its Final Report on August 26, 2008, or at the time of filing of the Motion to Supplement the Statement of Costs on October 21, 2009.

The Board requests that the Court grant this Second Motion to Supplement the Statement of Costs and assign additional costs in this case totaling \$6,620.51. The Board also requests that

the Court order Respondents American Family Prepaid Legal Corporation, Heritage Marketing and Insurance Services, Inc., Jeffrey Norman, and Stanley Norman, jointly and severally, to provide reimbursement of costs incurred by the Board and Relator in the total amount of \$53,645.43 (as set forth in Exhibits "2," "3," and "4").


