

Dear Justice Pfeifer:

The 02/06/10 article by Dispatch reporter James Nash stated, as the senior justice left on the Court after the en masse recusal of 5 of your compatriots, including Chief Justice Moyer, that you would be appointing their replacements; therefore, I felt it prudent to follow-up my Feb. 4, 2010 letter to you.
