


MEMORANDUM IN SUPPORT

Plaintiff-Appellant Mary Jo Hudson, Superintendent of Insurance, respectfully requests a ten (10) day extension of time to file her reply brief in this matter under S.Ct.Prac.R. 14.3(B)(2)(b). 
